It can also reverse coral bleaching in key areas and potentially mitigate the worst effects of climate change in oceanic and coastal environments. Marine Permaculture grows seaweed and fish habitat, which enable growing hundreds of tons of fish and thousands of tons of marine biomass each year per square kilometer. Over the past several years, the Climate Foundation has observed mass coral bleaching globally. For example, coral bleaching observed in Hawaii in 2015 was the worst bleaching event in the last half a century on Hawaii. These bleaching events are occurring with increasing frequency, representing dire consequences associated with global warming that marine permaculture can potentially address in the long term. A successful demonstration of marine permaculture infrastructure will pave the way to protect high-value reefs across tropical oceans.
