Conversion of human waste into bio char using pyrolysis at a community scale. In 2014, Climate Foundation developed and demonstrated a biochar reactor in New Delhi and Bangalore, India. This reactor is capable of treating sewage sludge and processing it into sanitary biochar.

4b (Code:) (Expenses \$ 68,757. including grants of \$) (Revenue \$ 64,630.)

Climate House: Our mission is to bring together researchers from diverse backgrounds under one roof to help build multidisciplinary integrative design teams that can solve global climate challenges. Part of this involves providing space for scholars to come to Woods Hole, learn and collaborate, who would otherwise have a hard time doing so. The Climate House provides such a location to conduct such interdisciplinary solution collaboration.

In 2014, Climate Foundation also researched and designed a new type of marine permaculture system. This work was presented to NOAA, National Marine Fisheries Service, Marine Biological Laboratory, Director of Aquaculture and the Woods Hole Oceanographic Institution, among others. This technology promises to restore fish populations and national fisheries. We plan to measure its carbon balance effects as well.

Climate Foundation is working to reverse coral bleaching globally. In 2014, Climate Foundation observed the mass coral bleaching globally. The coral bleaching observed in Hawaii was the worst bleaching event in the last half a century on Hawaii. Climate Foundation conducted planning meetings with the Honolulu SeaWater Air Conditioning corporation, planning the development of a reef cooling system for protecting coral reef from peak summer temperatures. This system will utilize the outfall temperatures of the cool seawater without transferring nutrients. A successful demonstration of this infrastructure will pave the way to protect high-value reefs across the tropical oceans.
